*She represented the ICTU on the Board of the Health and Safety Authority of Ireland, the European Commission's advisory committee on the free movement of workers and in the ILO as well as on ETUC committees and working groups. She is a member of the International Centre for Trade Union Rights.*

*Esther started her trade union career in the 1980s when she was elected as a shop steward. She was political adviser to the Irish Minister for Social Affairs (now Deputy Prime Minister) Joan Burton before moving to the ICTU in 1993.*
